<p>Triple P & DEI – For Discussion</p> <p>The issue of whether Triple P has evolved to meet the needs of all our communities in relation to diversity, equity & inclusion was raised at our May Lead Table Meeting. Are we confident that the resources are adaptable enough to be culturally relevant to any family? We discussed how to further explore this issue. Gwendy shared that at the spring practitioners meeting Joseph shared that within an Indigenous context they do not make changes to Triple P because the strategies align. They provide the type of support families ask for and meet them where they are. Emily pointed out that Triple P serves families globally; if we look at their research base you will find it broad. Mattea, Fiona and Joanna all shared that their organizations see Triple P as one of a host of options for families. It was observed that the format of Triple P is rigid, not necessarily</p>
